## Notice Concerning Change in Specified Associated Corporation

Nippon Accommodations Fund Inc. ("NAF") hereby provides notice of a change in a major associated corporation (specified associated corporation) of Mitsui Fudosan Accommodations Fund Management Co., Ltd. ("the Asset Management Company"), to which NAF entrusts asset management services, as shown below.

1. Events leading up to the change

Mitsui Fudosan Residential Co., Ltd. will fall under the category of specified associated corporation (corporations that conduct transactions stipulated in Article 29-3, Paragraph 3, Item 1 of the Order for Enforcement of the Financial Instruments and Exchange Act), as the total amount NAF paid to Mitsui Fudosan Residential Co., Ltd. as consideration for its acquisitions of real estate during the past three years from the last day of the 23rd Period (from March 1, 2017 to August 31, 2017) is equivalent to 20% or more of the sum total of the amount NAF paid to or received from Mitsui Fudosan Residential Co., Ltd. as considerations for its acquisitions or dispositions of real estate, etc. (real estate, land lease rights or superficies, the same applies hereinafter) or trust beneficiary interest in real estate, etc. during the same period.
