## Notification of Amendment of Articles of Incorporation and Election of Directors

This is to notify that at the Board of Directors meeting on April 14, 2009, Nippon Accommodations Fund resolved that the following Election of Directors and changes to the Articles of Incorporation will be put up for discussion at the Fourth General Meeting of Unitholders planned for May 22, 2009.

This proposal will become effective upon approval at the above General Meeting of Unitholders.

- 1. Summary of, and Reasons for, the Amendment of the Articles of Incorporation
  - (1) Make required revisions to text etc., in order to respond to the so-called change to electronic form of investment securities, according to the Law for Partial Amendments to the Law Concerning Book-entry Transfer of Corporate Bonds and Other Securities for the Purpose of Rationalizing of the Settlement for Trades of Stocks and Other Securities (2004 Law No.88), enforced on January 5, 2009.
  - (2) Prepare required provisions in response to legal amendments to the Special Taxation Measures Law concerning the definition of a "qualified institutional investor", deductibility requirements for paid dividends, handling when an investment corporation merges, etc.
  - (3) In addition to the above, provisions shall be added, deleted, expressions changed and clarified, etc. as necessary.

## 2. Election of Directors

The elected terms of all Executive Directors (2) and all Supervisory Directors (3) end on October 12, 2009, but they will temporarily resign with the closing of this General Meeting of Unitholders, and 2 Executive Directors and 3 Supervisory Directors are to be elected again.
