Notification Concerning Completed Acquisition of Domestic Real Estate Trust Beneficiary Interest

This is a notification that Nippon Accommodations Fund Inc. ("NAF") completed its acquisition of the domestic real estate trust beneficiary interest ("Trust Beneficiary Interest") noted below which was announced in the "Notification Concerning Acquisition of Domestic Real Estate Properties and Domestic Real Estate Trust Beneficiary Interest" dated February 10, 2011.

An on-site investigation of the Trust Beneficiary Interest property on the effects of the Tohoku district – off the Pacific Ocean Earthquake of March 11, 2011 conducted by a building investigation company confirmed some minor damage to the property. However, NAF has judged that this will not be an obstacle in acquiring and/or managing the Trust Beneficiary Interest. Further, based on the "Contract for the Sale of Real Estate Trust Beneficiary Interest with Condition Precedent" etc., concluded between NAF and the below mentioned seller on February 10, 2011, the seller will be responsible for the repair of damages.
